

4. Interested eligible Tenderers may obtain further information and inspect the Tendering Documents at the office of **The Secretary of the Tender Board, Kahama Town Council, P.O Box 472, Kahama** from 7:30am to 3:30pm on Mondays to Fridays inclusive except on public holidays.
5. A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of **Tshs 100,000/= (One Hundred Thousand)**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Town Treasurers' Office.

6. All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.
7. All Tenders in One Original plus Two Copies, properly filled in, and enclosed in plain envelopes must be delivered to the address Secretary of The Tender Board, Kahama Town Council, P.O. Box 472, Kahama at or before 10:30am, Friday 24th March, 2017. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the Kahama Town Council Hall, Located at Tabora Road in Kahama Town at Their Own Cost.
8. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
